
The California Victim Compensation Program (CalVCP) can reimburse victims of violent crime for certain crime-related expenses. The crimes that are covered include: domestic violence, child abuse, sexual and physical assault, homicide, robbery, drunk driving and vehicular manslaughter. Family members and dependents may also qualify for assistance from CalVCP.

CalVCP can help victims of crimes that occur in California as well as California residents who become victims while visiting other states or countries.

Expenses that can be covered by CalVCP include:

- Medical and Dental Care
- Mental Health Treatment
- Funeral Expenses
- Income and Support Loss
- Rehabilitation
- Relocation



CalVCP cannot pay any expenses that are not related to the crime, expenses already paid by insurance or another reimbursement source, expenses for lost, stolen or damaged property (with the exception of certain medical or medically-related equipment, prosthetics, orthotic appliance etc.) or damages for pain and suffering.
