THE BOARD OF SUPERVISORS OF THE COUNTY OF LASSEN, STATE OF CALIFORNIA DOES ORDAIN AS FOLLOWS:

SECTION ONE: Purpose and Intent. Correction of Ordinance 467A-210, to reflect a determination made by Lassen County that the intent of Section Three of Ordinance 467A-210 was to rezone from A-1 (General Agricultural) to Open Space (O-S), only those federal lands (Lassen National Park) administered by the National Park Service. This correction would remove Assessor's Parcel Numbers 097-240-001, 002, 004, 005, 010, 011, 012, 014, and 015, which are privately owned, from the Open Space Zoning District, and pursuant to Section Four of Ordinance 467A-210 would place said Parcels in the U-C-2 (Upland Conservation Resource Management) Zoning District.

SECTION TWO: Correcting Statement. The zoning change (A-1 to O-S) effectuated by Section Three of Ordinance 467A-210, over the area described therein, applies only to federal lands (Lassen National Park) administered by the National Park Service.
