1:30 p.m. Initial Study 2021-006, USE PERMIT #2021-009, & RECLAMATION PLAN

#2021-003, Geofortis Minerals, LLC. Proposal for a Use Permit and Reclamation Plan for an approximately 83-acre pozzolan surface mine. If approved, the permit would allow for daytime mining and screening operations up to seven days a week and allow for approximately 10.61 million cubic yards (500,000 cubic yards annually) of material to be mined with a proposed end date of 2070. The proposed site is located on four separate parcels including a 72.690-acre parcel, a 153.230-acre parcel, and a 161.360-acre parcel all owned by Avalanche Funding LLC; and an 80-acre parcel owned by the BLM. The parcels are zoned A-1 (General Agriculture District) and are designated Extensive Agriculture by the *Lassen County General Plan 2000*. The Project site is located in Lassen County approximately 5.5 miles north of the intersection of US Highway 395 and California State Route 70. and Asphalt Products, Inc. Proposed five-year extension of existing Interim Management Plan #5-01-87 (approved by Planning Commission on June 5, 2013, by Resolution #6-01-13 and extended on June 6, 2018 by Resolution 6-06-18), to allow for the continuation of the temporary plan of mining operations, to be in effect during idle production periods when operations are reduced by more than 90 percent of maximum production. The existing approved Interim Management Plan is considered a minor amendment of approved Reclamation Plan #3-01-88 and the proposed extension will renew said Interim Management Plan for an additional period not to exceed five years, which is the second and final allowable extension.
