B. Cal-Aim/Care Court - *Jennifer Branning reported we were approved for Round 1 Funding. Planning to hire a consultant for Round 2 plan for system data sharing. The plan will include working on 90-day transitioning with housing and wraparound focus. Round 2 application is due December 31, 2022. Danielle Sanchez reported Care Court passed on Wednesday, September 14, regarding treatment for those living on the streets with mental illness. 7 counties (Glenn, Orange, Riverside, San Diego, Stanislaus, Tuolumne and San Francisco) must start by October 1, 2023. The remaining 51 counties must begin by December 1, 2024. Handout with more information provided via email.*

C. Data Update – *Linsay Adams mentioned caseload numbers in Adult Supervision are 39 PRCS, 6 Mandatory Supervision, 75 Felony Supervision, 11 Pretrial. Of those, there are 24 Low Risk, 29 Moderate Risk, and 74 High Risk.*

D. Probation/DRC Updates – *Jennifer Miller reported she will be reviewing Riverside County incentive matrix. She reported 1 new Probation Assistant and 1 new Deputy Probation Officer who is currently in CORE. No changes in the DRC/VIBE Program, still no Program Services Manager at this time. The Probation Department will be starting to conduct more searches in the next month.*
