ORDINANCE NO. 2019-07

AN ORDINANCE OF THE COUNTY OF LASSEN AMENDING COUNTY CODE PERTAINING TO ENVIRONMENTAL HEALTH FEES

The Board of Supervisors of the County of Lassen ordains as follows:

SECTION 1: The County of Lassen provides certain services to individuals and organizations that are considered extraordinary levels of service, or are services for which charges or other compensation are authorized pursuant to applicable laws.

SECTION 2: The County Department of Health and Social Services has calculated an average cost for providing services and determined that certain fees, rates and charges must be adjusted to in an amount reasonably necessary to recover a portion of the County's cost of providing those service or product.

SECTION 3: The Board of Supervisors finds that it is in the public interest for the County to continue to provide these services, that the proposed fees, rates and charges represent the reasonable cost of providing the services, and thus such fees, rates and charges comply with all legal requirement, including but not limited to Article XIII C of the California Constitution.

SECTION 4: Section 7.30.200 of the Lassen County Code is hereby amended to read as follows:

The fee schedule for underground storage tanks in Lassen County shall be as set forth in Title 3 of the Lassen County Code."

SECTION 5: Section 3.18.120 of the Lassen County Code shall be enacted to read, in its entirety, as follows:

"3.18.120 Environmental Health fees.

The following fees, rates and charges pursuant to this section are in addition to third party fees and vendor charges, including but not limited to, County, State or Federal fees and surcharges.

SECTION 9: Subsection p of Section 3.18.090 of the Lassen County Code is hereby amended to read as follows:

"p. Reserved"

SECTION 10. All prior or concurrent ordinances and resolutions which relate to the establishment and modification of fees charged by the Department of Environmental Health and Department of Planning and Building shall remain in full force and effect to the extent not expressly revised herein.

SECTION 11. If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The County Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

SECTION 12. This ordinance shall take effect and be in force thirty (30) days after its final adoption. It shall be published in the Lassen County Times, a newspaper of general circulation in Lassen County, according to law.
