1:15 p.m. PUBLIC HEARING: Interim Management Plan (IMP) #1997-4 Extension,

California Department of Transportation. Proposal for a five-year extension of existing IMP #1997-4 (approved by Planning Commission on July 5, 2012 by Resolution #7-03-12), to allow for the continuation of the temporary plan of mining operations, to be in effect during idle production periods. The existing approved IMP is considered a minor amendment of approved Reclamation Plan #1997-4. The IMP was extended on July 5, 2017 by Resolution 7-03-17 and the proposed extension will renew said IMP for an additional period not to exceed five years which is the final allowable extension pursuant to Public Resources Code § 2770(h)(2)(A). The surface mining operation is currently situated on 6 acres of a 21.49-acre parcel managed by the Bureau of Land Management. The subject parcel is zoned U-C-2 (Upland Conservation/Resource Management District) and is designated Extensive Agriculture by the Lassen County General Plan, 2000. The surface mining operation is located approximately 300 feet east of Highway 395 and 70 miles northeast of Susanville, CA via Highway 395. A.P.N.: 019-110-007.
